Agriculture

- Each exhibitor is allowed to enter only one division i.e.: Youth, Adult Open, or Golden
- Each exhibitor is allowed one entry per class with a maximum of six entries.
- Entries must be produced in the 2025 growing season. All entries must be fresh and not frozen or preserved in anyway.
- Entries entered in the CCAF in 2024 will not be eligible for future CCAF contests. Entries entered in previous Chattooga County Agricultural Fair competitions are not eligible for re-entry. All products must be produced by the exhibitor. No commercially grown products are allowed.
- Plates and display cups will be provided by CCAF. See specific classes for quantity required.
- Utmost care will be taken in displaying entries. The CCAF and associates are not responsible for mishaps or damages.
- Entries will be received only on Wednesday, August 20, 2025 at the Chattooga County Agriculture Building between 1:00 pm and 6:00 pm. There are no exceptions.
- Upon registration, each contestant will be required to fill out entry tags for each entry.
- Judging will take place on August 21, 2025 and will not be open to the public.
- 3 placings will be awarded in each category, 1st, 2nd, and 3rd with one Grand Champion per division per the judging panel's discretion (all classes combined). One Best in Show will be awarded (all divisions and classes combined). Honorable mentions will be awarded at judging panel's discretion.

Agriculture Continued

- Any entry that does not meet the rules and regulations as specified for the category entered will not be eligible for judging and will be displayed as exhibition only.
- Entries will remain on display at the CCAF for the duration of the fair. Any alterations or removal will result in premiums/awards forfeited and will lead to ineligibility in future CCAF contests/exhibit participation.
- Entries and premiums will be available for pick up on Monday, August 25, 2025 from 10:00 am to 6:00 pm. Receipt for your exhibits MUST accompany pick up. Any entry not picked up on August 29, 2025 will become property of the CCAF and will be donated as the CCAF determines.

ARTS

- Each exhibitor is allowed to enter only one division, i.e. Youth, Adult Amateur, Adult Open, or Golden
- Each exhibitor is allowed one entry per class with a maximum of 6 total entries.
- All artwork must be original and produced by the entrant.
- Entries may be made by Chattooga County residents and surrounding counties.
- Any artwork entered in the CCAF in 2024 will not be eligible for future CCAF contests. Entries entered in previous Chattooga County Agricultural Fair competitions are not eligible for re-entry.
- Maximum dimensions for drawings and paintings, including framing, will be 11" x 14". All artwork MUST come ready to hang. Any submission that does not meet this requirement will not be allowed for submission.
- Sculptures must be submitted with a base for support (if needed) and fit within a 24" x 24" space and not exceed 24" in height.
- Utmost care will be taken in hanging and displaying of artwork. The CCAF and associates are not responsible for mishaps or damages.
- Art entries will be received on Monday, August 18, 2025 from 2:00 pm-6:00 pm and Tuesday August 19, 2025 from 9:00 am-1:00 pm at the Chattooga County Agriculture Building. There are no exceptions.
- The back or bottom of each entry must bear name, telephone number, division and class being entered.
- Art works judging will take place on August 20, 2025 and will not be open to the public.
- Three placings will be awarded in each class, 1st , 2nd , and 3rd , with one Grand Champion in each division (all classes combined) per the judging panel's discretion. One Best in Show will be awarded (all divisions and classes combined). Honorable mentions will be awarded at judging panel's discretion.

Arts

- Any entry that does not meet the rules and regulations as specified for the category entered will not be eligible for judging and will be displayed as exhibition only.
- CCAF reserves the right to refuse entry if the artwork entered is offensive or does not represent the CCAF in a positive manner. This decision is at the discretion of the CCAF Council and Blue Ribbon Committee.
- Artwork will remain on display at the CCAF for the duration of the fair. Any alterations or removal will result in forfeiture of premiums/awards and exhibitor will be ineligible to participate in future CCAF contests/exhibits.
- Artwork and premiums will be available for pick up on Monday, August 25, 2025 from 10:00 am to 6:00 pm. Receipt for your exhibits MUST accompany pick up. Any artwork not picked up on August 29, 2025 will become property of the CCAF and will be donated as the CCAF determines.

Division (One division entry allowed per exhibitor)

- Adult Amateur - 18+years – this class is for the beginner or amateur who has been painting/drawing/sculpting for less than 5 years and has not been paid for their works
- Adult Open - 18+years – this class is open for any teachers, professionals, or anyone who has received pay for services or given instructions be it paid or unpaid in the field of art must enter this division.

Food Preservation

- Each exhibitor is allowed to enter only one division, i.e. Youth, Adult Open, or Golden
- Each exhibitor is allowed one entry per class with a maximum of **ten** entries total.
- All entries must be produced with current 2025 season's produce.
- Entries entered in the CCAF in 2024 will not be eligible for future CCAF contests. Entries entered in previous Chattooga County Agricultural Fair competitions are not eligible for re-entry.
- All entries will be in quart, pint, or half pint brand name jars. Jams, jellies, and preserves will be accepted in jam/ jelly jars.
- Entries will not be accepted with wax, ribbons, or décor on the lid.
- All products must be processed according to the most recently recognized canning methods in the Ball Blue Book and UGA Extension publications. All products must meet USDA recommendations. Contact the Chattooga County Extension if you have questions.
- Canning jars with new lids and rings must be used. Mayonnaise jars, etc. will not be accepted. Rusted lids or leaking jars will not be accepted.
- All dried food entries must be entered in a canning jar (see above) with the contents labeled on the top of the jar.
- Utmost care will be taken in displaying entries. The CCAF and associates are not responsible for mishaps or damages.
- Entries will be received on Monday, August 18, 2025 from 2:00 pm to 6:00 pm and Tuesday, August 19, 2025 from 9:00 am to 1:00 pm at the Chattooga County Agriculture Building. There are no exceptions.
- Upon registration, each contestant will be required to fill out entry tags for each entry.
- Judging will take place on August 20, 2025 and will not be open to the public.

Horticulture

- Each exhibitor is allowed to enter only one division, i.e. Youth, Adult Open, or Golden
- Each exhibitor is allowed a maximum of 8 entries with no more than one per cultivar (variety). Only one entry **PER household** is allowed for any one class.
- Entries may be made by Chattooga County residents and surrounding counties.
- Entries entered in the CCAF in 2025 will not be eligible for future CCAF contests. Entries entered in previous Chattooga County Agricultural Fair competitions are not eligible for re-entry.
- All horticulture specimens must be fresh plant material grown by the exhibitor.
- Container grown plants must have been in the exhibitor's possession at least 90 days except multiple plantings, which must have been in the exhibitor's possession at least six weeks.
- Cut annual, biennials and perennials must have been in exhibitor's possession from seeds, cuttings and immature plants and grown to maturity. Bulbous blooms must have been in exhibitor's possession from planting of bulb, corm, tuber, or rhizome or it must have been cared for as a mature plant for at least 90 days.
- All horticulture specimens must be identified by its binomial name or currently accepted scientific identification. Common name may also be given in addition to the scientific name. Exhibitors are requested to research the botanical names for all entries prior to entering.
- Containers for container grown plants may not exceed 12" at the widest point of diameter. Double potting is allowed.
- Cut specimens must be exhibited in clean, clear glass bottles (no lettering), in size appropriate to the specimen, supplied by exhibitor. No plastic containers will be accepted.

HORTICULTURE (continued)

- Cut specimens should not have any foliage below the water line.
- Entries of cut specimens may be staged with a small amount of clear plastic wrap or bubble wrap furnished by the exhibitor for inconspicuous wedging in the neck of the bottle to assure that the specimen stands straight.
- Cut specimens may not exceed 30" from cut end of stem to tip of specimen and must have several nodes (node: the place on a stem where a leaf, shoot, branch, or flower arises), and an apical tip.
- Only one specimen per container except where otherwise specified or one stem per cut specimen
- Utmost care will be taken in displaying entries. The CCAF and associates are not responsible for mishaps or damages.
- All classes will be received on Wednesday, August 20, 2025 at the Chattooga County Agriculture Building between 1:00 pm and 6:00 pm. The only exception will be cut blooming specimens that last one day such as day lilies and roses.
- **ONLY CUT BLOOMING- day lilies and rose** specimens will be received on Thursday, August 21, 2025 at the Chattooga County Agricultural Building between 8:00 am and 10:00 am. There are no exceptions.
- Upon registration, each contestant will be required to fill out entry tags for each entry.
- Judging will take place on August 21, 2025 and will not be open to the public.
- Three placings will be awarded in each category, 1st, 2nd, 3rd with one Grand Champion per division at the judging panel's discretion (all classes combined). Honorable mentions will be awarded at judging panel's discretion.
- Any entry that does not meet the rules and regulations as specified for the category entered will not be eligible for judging and will be displayed as exhibition only.

- Any handiwork entered in the CCAF in 2024 will not be eligible for future CCAF contests. Entries entered in previous Chattooga County Agricultural Fair competitions are not eligible for re-entry.
- Utmost care will be taken in hanging and displaying of handiworks. The CCAF and associates are not responsible for mishaps or damages.
- Entries will be received on Monday, August 18, 2025 from 2:00 pm to 6:00 pm and Tuesday, August 19, 2025 from 9:00 am to 1:00 pm at the Chattooga County Agriculture Building. There are no exceptions.
- Names on entered pieces must not be visible. Can be covered with masking tape for judging purposes.
- Exhibitors must have legible name and contact information somewhere on their entry.
- Exhibitors are encouraged to bring their entries in labeled pillow cases.
- Upon registration, each contestant will be required to fill out entry tags for each entry.
- Needlework judging will take place on August 20, 2025 and will not be open to the public.

- Each exhibitor is allowed to enter only one division, i.e. Youth, Adult, Golden Age or Advanced
- Each exhibitor is allowed one entry per class with a maximum of 6 total entries.
- All images must be original and taken by the entrant. No alteration, including digital enhancement, computer editing, or photo stacking, is allowed.
- Entries may be made by Chattooga County residents and surrounding counties.
- Any photographs entered in the CCAF in 2024 will not be eligible for future CCAF contests.
- Each photograph must be no larger than an 8" x 10" photograph fixed in a matte with maximum dimensions of 11" x 14". The CCAF Blue Ribbon Committee will attach photographs to display boards with clips provided by the CCAF. Photographs not matching the required criteria will not be eligible for entry. Entries entered in previous Chattooga County Agricultural Fair competitions are not eligible for re-entry.
- ABSOLUTELY NO FRAMED PHOTOGRAPHS WILL BE ACCEPTED
- Utmost care will be taken in hanging and displaying of photographs. The CCAF and associates are not responsible for mishaps or damages.
- Entries will be received on Monday, August 18, 2025 from 2:00 pm to 6:00 pm and Tuesday, August 19, 2025 from 9:00 am to 1:00 pm at the Chattooga County Agriculture Building. There are no exceptions.
- The back of each photograph must bear name, telephone, division and class being entered.
- Upon registration, each contestant will be required to fill out entry tags for each photograph.
- Photography judging will take place on August 20, 2025 and will not be open to the public.

- Three placings will be awarded in each category, 1st, 2nd, 3rd with one Grand Champion per division per the judging panel's discretion (all classes combined) One Best in Show will be awarded (all divisions and classes combined). Honorable mentions will be awarded at judging panel's discretion.
- Any entry that does not meet the rules and regulations as specified for the category entered will not be eligible for judging and will be displayed as exhibition only.
- CCAF reserves the right to refuse entry if the photograph entered is offensive or does not represent the CCAF in a positive manner. This decision is to the discretion of the CCAF Council and Blue Ribbon Committee.
- Photographs will remain on display at the CCAF for the duration of the fair. Any alterations or removal will result in forfeiture of premiums/awards and exhibitor will be ineligible to participate in future CCAF contests/exhibits.
- Photographs and premiums will be available for pick up on August 25, 2025 from 10:00 am to 6:00 pm. Receipt for your exhibits **MUST** accompany pick up. Any photographs not picked up on August 29, 2025 will become property of the CCAF and will be donated as the CCAF determines. Any prize money not claimed will be donated as CCAF determines.

Honey Show Rules 2025

- Entries will be accepted **only** on Wednesday, August 20, 2025, 1 pm to 6 pm at the Chattooga Co Ag Building. No late entries will be accepted.
- Judging will take place Wednesday, August 20, 2025 at 6:00 p.m. Judging will be based on the rules and standards provided by the Honey Association. Rules for 2025 show are specific to this show. Exhibitors are not allowed in the judging area until after results are announced.
- Contestant may enter in any or all classes, but may enter only once per class. The same honey container cannot be entered in both the black jar class and another extracted honey class.
- Exhibitor's name must not be shown. Do not label products in any way. An identifying code sticker will be assigned to your entry at registration.
- All honey and wax exhibited must be the bona fide product of the exhibitor's own bees and produced within the last 12 months. Beeswax entries must be pure beeswax. No item submitted in a previous Chattooga Co. Fair Honey Show will be eligible.
- All entries for honey products and candles must be submitted in duplicate, i.e. two (2) matching jars of honey, two (2) boxes of cut comb, or two (2) candles. All entries must be identical. The only exemption is black jar; only one jar is required.
- Submit extracted honey in two (2) standard one-pound Queenline-type jars or pint jars. Either plastic or glass is acceptable. Jars with tamper-proof seals will not be judged. Pint jar entries will be judged with the same criteria as Queenline jars. In addition, no pint or quart canning jars will be judged (i.e. Mason, Ball, Kerr).
- Submit chunk honey in two (2) standard one-pound chunk honey jars with wide mouths and straight sides. NOTE: A smooth sided tall jelly jar will be accepted. The chunk of comb must be in one piece.
- The sole judging criterion in the black jar class is taste.
- An entry of cut comb honey is two (2) boxes. The boxes must be transparent on all sides made for displaying cut comb.

Livestock - General Information

Exhibitor's Pass - Each exhibitor will receive **4 armbands** in the mail prior to the event. **Any additional guest must purchase a \$5.00 general admission gate ticket.**

Livestock Parking will be available for trailers only and all other vehicles will be in general parking.

Health Regulations - (Requirement for the Exhibition of Livestock in Georgia)

All animals being exhibited in any type of livestock show (local, county, area, district, or state) must have an official certificate of veterinary inspection (health certificate). This certificate of veterinary inspection must be issued within 30 days of the exhibition - with the exception of 4-H and FFA shows. See the current year Georgia 4-H and FFA State Livestock Shows Rules and Regulations for specific information for 4-H and FFA health certificates. All other livestock exhibitors must follow rules and regulations as outlined in the "Health Requirement for Exhibition of Livestock in Georgia," revised October 7, 2003, by the Georgia Department of Agriculture. No animals will be allowed entry onto the fairgrounds without the proper health records and test requirements.

General Rules -Applicable to all Livestock

- All entries shall be classified immediately upon arrival and classification cannot be changed.
- All livestock and poultry must conform to Health Regulations as outlined above.
- All livestock may be subject to health inspection by an Official State Veterinarian.
- The livestock barn will be open during all fair hours from August 21 - 24, 2025.
- Livestock receiving hours are before fair operating hours. Vehicles will be allowed to pull up to the barn, unload in a timely manner, and drive to the designated parking area. Please refer to each species for receiving dates and hours. Livestock may be removed following the show. Vehicles will be permitted on the fairgrounds in the designated loading/parking areas and for designated times only.
- Outside food may only be brought on to the fairgrounds before operating fair hours.
- The contestants must be present at the time of judging or make prior arrangements to have their animals shown due to a legitimate excuse.
- Premium awards will be awarded for places 1st—5th in weight and showmanship classes. First- \$25 Second- \$20 Third- \$15 Fourth- \$10 Fifth- \$5

- Grand Champion payouts are \$75 and Reserve Grand Champion payouts are \$50. Ribbons will be given for placings 1-8. Division Champions will be awarded (beef) First- \$25 Second- \$15.
- Premiums will be paid by the Treasurer of the Chattooga County Agricultural Fair.
- The fair council reserves the right to cap the show based on available space.
- All livestock must have a creditable showing in order to qualify to receive a premium.
- Premiums will not be awarded without entry fees paid.
- There will be a \$35 processing fee on all returned checks.
- Where there is no competition in a class and champion showing, either second prize or reserve champion money may be given.
- Each exhibitor must furnish their own feed, feed pan, water pail, and show supplies. The fair will furnish the bedding, electric power, and water supply. It is the responsibility of each exhibitor to feed, water, clean up after their animals, and provide general care for their animals while at the fair.
- Veterinarian service for all animals, while at the fair, will be made available at the owner's expense.
- The fair will not be responsible for loss or damage to any exhibit and will give the best care and attention to prevent loss or damage.
- There will be showmanship classes. Classes will be determined by grade level.
- An exhibition "fun class" for pee wee showmen will take place prior to the grade showmanship classes. There is no entry fee, and only ribbon placings will be awarded. Very young children may need to be accompanied into the ring.
- We shall honor the Statement of Relation (Memorandum of Understanding) between Vocational Education and the Cooperative Extension which is considered the official agreement. This agreement guides 4-H and FFA participation in events. The intent of the agreement is to support youth participating in both organizations with different project areas and to disallow a young person from competing in both organizations with the same project area in the same year.
- Application for all livestock entries shall be in the hands of the proper livestock department representative no later than Friday, August 13, 2025.
- Market goat, Market Lamb, Beef, and Dairy entry is a non-refundable fee of \$15 per animal entered with a maximum of three entries per species.
- Showmanship is included in this fee. There will be a \$15 late fee to any animals added on show day.
